for 2024 selling season

Early Payment Discounts

Dated product invoices qualify for this payment discount schedule:

| Payment Received on or before: | Discount | Payment Received on or before: | Discount |
|--------------------------------|----------|--------------------------------|----------|
| February 29, 2024 | 7% | July - August 31, 2024 | 2% |
| March - April 30, 2024 | 5% | September - October 31, 2024 | 1% |
| May - June 30, 2024 | 4% | November - December 2024 | 0% |

Our Early Payment Discounts apply only to imprinted calendars that start with January 2025. We invoice all calendar orders when the product leaves the factory. The website will indicate the savings available if you pay early. The discount percentage is calculated on the date that the payment is received in full on orders, order-to-storage notices or invoices.

To qualify for Early Payment Discounts:

- You must have a line of credit with us; you cannot be a prepay customer.
- Your imprinted calendar order must be received and processed with a sales order number on file. Please allow adequate time for us to process your order.
- You must pay the order/invoice in full, including freight and tax. (Payment remit MUST be attached.)

All other items are invoiced in accordance with account terms. Discounts are not offered with consolidated invoicing.

5% Early Ship Discount

You can also qualify for a 5% Early Ship Discount on the already reduced Early Buyer prices published for calendar products. To qualify for the Early Ship Discount, your purchase order must meet these criteria:

- Orders must ship on or before July 1, 2024. Be sure to allow standard production time to meet the ship date.
- Specify shipment "when ready but not later than July 1, 2024." We will ship your order when it is completed unless a storage release date is specified.
- Our Early Ship Discount does not apply to non-dated material, Triumph® Calendar diary products, co-ops, customs, large order price quotes, special price quotes, sample orders, or distributor self-promotion orders.

All credit card payments are processed in USD and will receive a 3% credit card processing fee. **Checks or ACH payments are not subject to the fee.**
