#### **Koozie® Brand REQUIREMENTS**

#### Trademark Use


- Only genuine Koozie Group<sup>®</sup> products may be branded as Koozie<sup>®</sup> products, and such products must be branded with the full product name as used by Koozie Group for that product.
- Do not use the word "Koozie" as a noun or in the plural form in any product names or product descriptions. For example, do not refer to drink coolers as "Koozies" to describe the product type; products should be referred to as "Koozie® can coolers."
- Always use "Koozie" as an adjective. When using "Koozie" to refer to products, all Koozie®-branded products should include the product name and trademark registration symbol after the Koozie trademark, such as "Koozie® bottle coolers," "Koozie® camp chairs," or "Koozie® tents."
- Koozie<sup>®</sup> can coolers should be distinguished from non-Koozie<sup>®</sup> can cooler products by placing Koozie<sup>®</sup> products under their own page heading. For example, on a website that has a "Drinkware" category, there should be separate sub-categories for non-branded products "Can Coolers" and for Koozie<sup>®</sup>-branded products "Koozie<sup>®</sup> Can Coolers."

#### **Search Terms and Paid Keywords**

**Search Terms:** On your website, Koozie<sup>®</sup> should only be used for Koozie<sup>®</sup>-branded products. In the Google Like Search (search bar/section), all search results should land on Koozie<sup>®</sup>-branded products only. Example shown below.




#### Internal Keyword Search Not Approved

- Internal Distributor Web Page Google Like Search (GLS) results in Koozie<sup>®</sup>-branded product AND non-Koozie<sup>®</sup>-branded product when "Koozie" is searched for
- Note: Of the 76 results in this example, 15 were Koozie® branded.








#### Logos
